Impressive rankings achieved in Latin America

Morison KSi has achieved further high rankings in the October edition of *International Accounting Bulletin (IAB)*.

The October edition of the IAB features a number of Latin American country surveys as well as the regional Latin American survey.

Morison KSi ranked number three in terms of total revenue and fifth in terms of staff in the Latin America regional survey.
